Sir,

1. The accused officials of Embassy of India, Riyadh (EOI) and Defense Attache stationed at EOI, with common criminal intent , conspired to make the petitioner disappear, as threatened in previous occasions also, so that the petitioner will not approach the courts and investigating agencies in India to investigate the corruption by the accused, identified the house location of the petitioner with help of Indian school staff, where the petitioners children are studying , and tried to kidnap the petitioner on July 7 2020 , and on its failure being the kidnap reported to police control room, Syrian national, employee of Eol , and in connivance with other accused, forged the letterhead, seal and signature of ambassador, Eol and submitted the same to Saudi police as genuine complaint of Eol, that the petitioner is defaming and obstructing the Eol, without following any due process or obtaining any authorization, to file a case against petitioner in the name of embassy of India Riyadh, and submitted false statement in Saudi court that the petitioner accepted guilt and apologized and thereby causing jail term for petitioner for 113 days and stop services order that may result in deportation. When the matter was considered by the Hon'ble High Court of Kerala, the EOI submitted false affidavit that EOI has no role in the arrest of the petitioner.
2. The fact that Eol is the complainant is recorded in the report of the Prosecutor and also the judgement of the criminal court of Riyadh.
3. even after duly notified, officials of Eol Riyadh abetted the crime by not taking any action against the forgery and misrepresentation and defamed the petitioner and mislead the public by making false statements against the petitioner in Hon'ble High court of Kerla and also in reply to prime ministers Grievance cell and RTI applications.
4. Reason of the enmity is the actions of the petitioner, that during the covid 19 pandemic, where petitioner helped the people in distress to file petitions and filed RTI applications to ensure compliance of SOP issued by Ministry of Home , Government of India and judgements issued by Hon'ble High courts of Delhi and Kerala, for assistance and safe repatriation of stranded Indian nationals , and due to the prior existing enmity with the petitioner due to his activities questioning the corruption in Indian schools under the EOI ,

Kindly register FIR and initiate investigation at the earliest.

As per para 3 of P1, the pleadings of the Ministry of External Affairs and Embassy of India is that.

the Embassy is willing to offer all assistance to the petitioner's son, should he approach them appropriately. She added that it will not be possible for the Embassy to address letters to the Courts, or the Office of the Governor of Riyadh, **merely on the asking the petitioner**, since this would be construed to be in violation of the diplomatic norms; and that, **in any event, this would not help the petitioner's son at all**. She argued that it is only if the petitioner is able to point out what exact assistance his son requires, can the Embassy offer it; adding that all such will be made available to him, as long as it is legally tenable.

As per para 5 of P1, the court has ordered to

5. I see no reason why the Embassy will not afford the afore to the petitioner's son. This is more so, because the petitioner's son appears to be having right of appeal, in which, perhaps legal assistance to be provided by the Embassy, if applied for, can help him in bringing out the truth, as he says. In the afore circumstances, I allow this writ petition to the limited extent of leaving liberty to the petitioner and his son to approach the competent officials of the Indian Embassy in Riyadh, with a written representation detailing the requests; and if this is done, **then all necessary assistance will be given to the petitioner's son, including for legal assistance in his appeal, or such other proceedings.**

I further order that, to the extent possible, every support will be given to the petitioner's son to obtain a Residential Permit as per law.

In obedience of the order of the Hon'ble High Court of Kerala, and considering the statements in court, I prefer this written representation detailing the requests as below.

Considering the national security interest in this case, where the credentials of an Embassy have been Misused/forged and diplomatic channels of communication violated, I offer my full cooperation.

As in previous similar situations, where people were trapped by miscreants, appropriate investigations and the findings need to be attached with the appeal petition.

Kindly provide legal assistance and necessary action to

1. Request for copy of the complaint received by the Riyadh police, based on which case number 411498581 dated 29/12/1441 was filed.

2. Investigate through appropriate Saudi Arabian Authorities on

a. How the Syrian national managed to submit a complaint on behalf of the Embassy of India without any authorization from the embassy of India.

- b. How the Syrian national managed to send the complaint to police bypassing the requirement of sending the communication through the Ministry of Foreign Affairs of Saudi Arabia.
  - c. How the Syrian national acquired the private rights of the embassy of India, without any authorization from the embassy of India.
3. Investigate through appropriate Indian investigating agencies like RAW/NIA/CBI on
- a. How the Syrian national managed to obtain or forge the credentials of the Embassy of India.
  - b. Other current or ex-employees of the Indian embassy / defense Attache who assisted the crime / took part in the criminal conspiracy to make the petitioner disappear.
  - c. Other current or ex-employees of the Indian embassy and Ministry of External Affairs who took part in the crime by denying/hiding the information.
  - d. Other current or ex-employees of Indian Embassy / Ministry of External Affairs / defense Attache who took part in the crime by destroying any evidence.
  - e. Other current or ex-employees of Indian Embassy / Ministry of External Affairs/ Ministry of Law who took part in the crime by submitting false and defamatory statements in courts.
  - f. Other current or ex-employees of Indian Embassy / Ministry of External Affairs who took part in the crime by providing false information to RTIs, Prime Ministers grievance cell, MP's etc.
  - g. Involvement of current or ex-employees / Managing council members of Indian Schools in Saudi Arabia in this crime.
  - h. Involvement of other persons or entities in this crime.
4. Obtain the reports of investigations as mentioned in paragraph 2 and 3 as evidence to prove that the complaint is not genuine and
- a. Withdraw the statement submitted by the embassy in Riyadh Criminal Court as the statement is false and misleading.
  - b. Issue a new statement to Riyadh Criminal Court clearly stating that the complaint filed in the name of the embassy is not genuine and not filed by the embassy or with any authorization of the embassy.
  - c. submit an appeal to His Excellency the Governor of Riyadh to appeal the conviction and remove the "Stop Service" order and any other penalties on the petitioner, so that the petitioner can find a new job, sponsor, and renew the residence permit.
  - d. Take necessary action to avoid the deportation of the petitioner.

2. Bank account got closed and the dues got released yesterday around 11.00 AM, Sale of the vehicle is in process as it is very difficult to find a buyer who would be willing to come to the police station to complete the formalities.

3. The final order dated .16 November 2023 was passed in the above case in Kerala High Court. The final order will be forwarded immediately on receipt of the certified copy of the order. It is requested to defer further action till then in the interest of justice.

4. If the embassy has no role in my arrest, the embassy should file a complaint with appropriate agencies, against the person / persons who forged the embassy's credentials to lodge the complaint against me and also against those who filed false statements in Saudi court that I have apologised and accepted that the allegations of corruption are baseless. , so that the investigation report can be submitted to appropriate authorities to quash the case.

As instructed and in obedience to your email dated.02 November 2023. I was present on 5th November 2023 (Sunday) at 0900 hrs at the Almanar Enforcement Police Department.

With the Assistance of officers from the embassy Mr. Rajiv Sikri and Mr. Wazir, I have completed some procedures and am now waiting for the result of the biometric check.

This process will result in deportation with GCC wide ban and will result in unquantifiable damages for me and my family.

I am attaching a screenshot of the process that can be followed to cancel these punishments on me so that I can continue working here in Saudi Arabia.

If the embassy can issue a letter to His Excellency the Governor of Riyadh, clearly explaining that the complaint based on which judgement was issued against me was not by the embassy and the result of some fraud and hence nullable, I can Appeal the conviction again, and avoid all these unnecessary issues.

Kindly issue necessary directions before it is not too late.

2. As instructed and in obedience to your email dated.02 November 2023.I will be present on 5th November 2023 (Sunday) at 0900 hrs at the Almanar Enforcement Police Department.

3. Though the Embassy reiterates to me and the Hon'ble High Court of Kerala that neither the Embassy lodged any complaint against me, nor the Embassy had any role in my arrest, the facts and evidence proves the contrary. Although My family informed you from day one, you are still not able to provide any proof that the embassy did not file this complaint. There are many witnesses who have seen embassy's officials taking part in this crime at various stages. The Embassy is responsible for the complaint filed in the letterhead of the embassy and its credentials, by its officials. I am not inclined to deny the judgement of the Hon'ble Criminal Court of Riyadh, which clearly states that the complaint that led to my arrest was made by the Embassy of India Riyadh. The report of the prosecution department and the bail order of the Personal Status Court also states the same. Also, through the letter you submitted in Criminal Court, in Riyadh, you virtually accept the ownership of the complaint and hence choose to issue pardon, even after we duly informed you to seek legal opinion before filing such a false statement in court. Also, your staff attended the trial for two days as your representative but failed to inform the court that this was not your complaint. Your failure to issue a clear statement, declining your involvement in the complaint, to the police, prosecution, and courts in Saudi Arabia, clearly indicate the control the criminals have over the embassy.

Also, the unfounded and defamatory allegations against me in the statements submitted by you in Hon'ble Kerala High Court also indicates your mala fide intention in this matter. Since the matter was brought to the knowledge of the Embassy, the embassy pretends to be helping me, but does everything to eliminate me and protect the criminals. If the embassy really wants to help me or prove the embassy's innocence, the embassy should file a complaint to the Police to prosecute the criminals, who illegally and fraudulently filed the complaint against me, misusing the credentials of the Embassy. The embassy's failure to seek due remedy itself proves the guilt.



4. I don't understand why the embassy insists on providing the ticket, though it is the responsibility of the sponsor.

5. The present course of action is in the guise of the directions of the Hon'ble High Court Of Kerala dated 15 September 2023 in WP(C) No. 21845 of 2023(E) titled Claramma Simon Vs Union of India and ors., but it is not in its spirit. The prayer in the writ petition is

"to take effective steps to set aside the conviction and finding of guilt of the son of the petitioner by the Criminal Court in Riyadh by intimating it, and the Governor of Riyadh, that the complaint against the son of the petitioner was made by a former staff of the embassy without necessary authorization and it has no complaints against the son of the petitioner, as he is unable to renew his resident permit in the Kingdom of Saudi Arabia,"

. The Hon'ble High courts order is

"Whatever be the merits of the assertions of the parties, the fact remains that as long as our citizen is abroad, facing a predicament, necessary conceal access and diplomatic support has to be offered. It is not sufficient that steps are taken and reported to this court, but it should be followed up meaningfully to obtain the desired results which is finally to have the son of the petitioner brought back to India."

The order is to provide the necessary support, to obtain the desired results so that I can travel to India. It is not saying to get me arrested by the police and speed up the deportation, thereby inflicting more punishment on me. The entire writ petition is to avoid deportation. If the embassy indeed want to comply with the order in true spirit, the embassy need to write a letter to the Saudi authorities as prayed for in the writ petition and remove the restrictions on me due to this case filed by the embassy, so that I can find a new sponsor and renew my residence permit and travel to India on exit and re-entry visa and visit my mother.

As instructed and in obedience to your email dated.29 October 2023..

I will be present on .5th November 2023 (Sunday) at 0900 hrs .at the Almanar.Enforcement Police Department .

I have the original passport with me and the previous Iqama . The latest Iqama is only digital and has no card. As per the verdict of the Labour Court, the sponsor is to provide the Ticket. I have attached the translation of the order of the labour court.

But I am afraid that the final exit is another punishment for me, as I would not be allowed to continue working in Saudi Arabia. Also I would not get a police clearance certificate and I would not be able to apply for any visa to any other country in future.

My wife and children are living here and they will have to suffer mental agony and face safety issues to live without me. My wife will be forced to resign her job and children will have to quit their studies mid session. The eldest son is in Grade 10 and preparing for the Board Examination.

It would be better if the embassy can convince the authorities of the facts and cancel the wrong verdict imposed on me and subsequent restrictions. Then I would be able to find a new job and renew my residence permit and come to India on an Exit and ReEntry Visa.

If I can continue working in Riyadh, I can also assist any investigation agencies if the Embassy would like to prosecute the criminals who forged the Embassy's credentials in Saudi Arabia .
