You are, therefore, requested to present yourself for a personal hearing before the Mission latest by forenoon of Sunday, June 07, 2020 with detailed explanations and corroborative evidences, if any, to substantiate your publicly made allegations. 3. We request you to take this notice on priority for visiting the Embassy on or before June 07, 2020 failing which the Embassy would have no option but to take appropriate legal recourse.
